- Design and deliver financial literacy workshops and awareness campaigns on budgeting, savings, and responsible borrowing.

- Act as the authentic voice and advocate for youth perspectives within our organisation.

##### **Strategic Insights & Influence**

- Conduct active listening sessions and gather qualitative and quantitative feedback on young people's financial needs and expectations.
- Synthesise market intelligence into clear, data-informed strategic recommendations.
- Present findings and recommendations directly to our Board of Directors and Management Team, influencing decisions on new services and product development.
- Track engagement metrics and demonstrate impact through reporting and analysis.

- Design innovative engagement models and pilot new approaches to youth outreach.
- Establish best practices in youth financial engagement that position People First Credit Union as a sector leader
- Build a scalable framework for sustainable youth involvement in our strategic planning.
